Associate Professor of Business Administration **Dr. Gregory Kivenzor** delivered a presentation at the 40th annual conference of the Academy of Marketing Science, held in May in Coral Gables, Fla. His research was focused on consumer typology in Russia.

In July, he took part in the World Marketing Congress in Reims, France. The Congress drew nearly 500 participants from 49 countries. Dr. Kivenzor chaired a special session called "Marketing in BRICS," which discussed the business climate and marketing issues in Brazil, Russia, India, China, and South Africa—the largest and fastest growing economies in four continents: Europe, Asia, South

America, and Africa. During the session, he also presented his research paper titled "The Luxury of Belonging to the Middle Class." Dr. Kivenzor has been asked to co-chair the newly-created track, "Marketing in BRICS," at this year's Congress in Atlanta, Ga.

This summer, he compiled and edited a new textbook, *Marketing and New Product Development*, published by McGraw-Hill, which contains relevant chapters from two different existing textbooks. He also contributed a new chapter to the book—"New Ideas, New Products, and New Ways to Market Them."

In October 2011, Dr. Kivenzor visited Plekhanov Russian Economic University in Moscow, Russia to teach a course on Marketing and New Product Development to graduate students from Russia, France, and Germany. He also facilitated a roundtable discussion with University faculty and administration and delivered a presentation about the ways American professors balance their time between teaching, research, and service obligations. He also expressed his willingness to participate in joint research with faculty from Plekhanov University.


